



REPORT OF THE INDEPENDENT ACCOUNTANT

To the management of Starfield Technologies, LLC (“Starfield”):

Scope

We have examined Starfield, subsidiary of GoDaddy Inc. (“GoDaddy”), management’s [assertion](#) that for its Starfield and GoDaddy Certification Authority (“CA”) operations in Arizona and Virginia, in the United States of America, for its CAs as enumerated in [Attachment B](#), Starfield has:

- disclosed its business, key lifecycle management, certificate lifecycle management, and CA environmental control practices in the applicable versions of its Starfield Technologies, LLC Certificate Policy and Certification Practice Statement (“CP/CPS”) enumerated in [Attachment A](#)
- maintained effective controls to provide reasonable assurance that Starfield provides its services in accordance with its CP/CPS
- maintained effective controls to provide reasonable assurance that:
 - the integrity of keys and certificates it manages is established and protected throughout their lifecycles;
 - the integrity of subscriber keys and certificates it manages is established and protected throughout their lifecycles;
 - subscriber information is properly authenticated; and
 - subordinate CA certificate requests are accurate, authenticated, and approved
- maintained effective controls to provide reasonable assurance that:
 - logical and physical access to CA systems and data is restricted to authorized individuals;
 - the continuity of key and certificate management operations is maintained; and
 - CA systems development, maintenance, and operations are properly authorized and performed to maintain CA systems integrity

throughout the period July 1, 2020 to June 30, 2021 based on the [WebTrust Principles and Criteria for Certification Authorities v2.2](#).

Starfield does not escrow its CA keys, does not provide subscriber key generation services, and does not provide certificate suspension services. Accordingly, our examination did not extend to controls that would address those criteria.

Certification Authority’s Responsibilities

Starfield’s management is responsible for its assertion, including the fairness of its presentation, and the provision of its described services in accordance with the [WebTrust Principles and Criteria for Certification Authorities v2.2](#).



Independent Accountant’s Responsibilities

Our responsibility is to express an opinion on Starfield management’s assertion based on our examination. Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether management’s assertion is fairly stated, in all material respects. An examination involves performing procedures to obtain evidence about management’s assertion. The nature, timing, and extent of the procedures selected depend on our judgment, including an assessment of the risks of material misstatement of management’s assertion, whether due to fraud or error. We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

The relative effectiveness and significance of specific controls at Starfield and their effect on assessments of control risk for subscribers and relying parties are dependent on their interaction with the controls and other factors present at individual subscriber and relying party locations. Our examination did not extend to controls at individual subscriber and relying party locations and we have not evaluated the effectiveness of such controls.

Inherent Limitations

Because of the nature and inherent limitations of controls, Starfield’s ability to meet the aforementioned criteria may be affected. For example, controls may not prevent, or detect and correct, error, fraud, unauthorized access to systems and information, or failure to comply with internal and external policies or requirements. Also, the projection of any conclusions based on our findings to future periods is subject to the risk that changes may alter the validity of such conclusions.

Independent Accountant’s Opinion

In our opinion management’s assertion, as referred to above, is fairly stated, in all material respects.

This report does not include any representation as to the quality of Starfield’s services other than its CA operations in Arizona and Virginia, in the United States of America, nor the suitability of any of Starfield’s services for any customer’s intended purpose.

Other Matter

Without modifying our opinion, we noted the following other matters during our procedures:

1	Certificate Validity	Starfield disclosed in Mozilla Bug 1662807 it issued 107 SSL certificates with validity periods greater than 398 days after the effective date for the new validity period maximum went into effect.



We have noted any instances of possible non-conformance above that are relevant to the CAs enumerated in [Attachment B](#). Starfield's assertion notes all instances of possible non-conformance, addressed by Starfield, during the engagement period, regardless of the particular CAs enumerated in [Attachment B](#).

Starfield's use of the WebTrust for Certification Authorities Seal constitutes a symbolic representation of the contents of this report and it is not intended, nor should it be construed, to update this report or provide any additional assurance.

STARFIELD TECHNOLOGIES, LLC MANAGEMENT'S ASSERTION

Starfield Technologies, LLC ("Starfield"), subsidiary of GoDaddy Inc. ("GoDaddy"), operates the Starfield and GoDaddy Certification Authority ("CA") services for the CAs enumerated in [Attachment B](#), and provides the following CA services:

- Subscriber registration
- Certificate renewal
- Certificate rekey
- Certificate issuance
- Certificate distribution
- Certificate revocation
- Certificate validation
- Subordinate CA certification and cross-certification

The management of Starfield is responsible for establishing and maintaining effective controls over its CA operations, including its CA business practices disclosure on its [repository](#), CA business practices management, CA environmental controls, CA key lifecycle management controls, certificate lifecycle management controls, and subordinate CA certificate lifecycle management controls. These controls contain monitoring mechanisms, and actions are taken to correct deficiencies identified.

There are inherent limitations in any controls, including the possibility of human error, and the circumvention or overriding of controls. Accordingly, even effective controls can only provide reasonable assurance with respect to Starfield's CA operations. Furthermore, because of changes in conditions, the effectiveness of controls may vary over time.
